The Giles County Public School System (GCPS) is soliciting bids for the purchase of the below item. We expect to take delivery immediately (please attach a copy of the window sticker and a picture of the truck with your bid price):

- Truck Specifications: ONE NEW OR USED 2018 OR NEWER box truck (Ford Transit 350 or equivalent) RWD 6-Speed Automatic with Overdrive, Class 2 (GVW 6001 – 1000), Gasoline Engine, Rear Wheel Drive, Automatic Transmission, Dual Rear Tires, Air-conditioning, Heating, Power Windows, Standard Cab, Back Up Camera,
- **Box Specifications**: Dimensions 12-14'L x 8'W x 7'H, Aluminum Construction, Flat Floor, E-Track tie down system on all interior walls, Roll-up Door, Lift Gate.
- If possible, would like the vehicle to have under 50,000 miles.

The selection process will be in compliance with the regulations under the provisions of the Virginia Procurement Act and Giles County School Board Policy. It is understood that GCPS reserves the right to cancel any contract resulting from this solicitation immediately upon providing notification to the contractor in writing from GCPS. This cancellation will be without liability or penalty to GCPS for breach of contract. GCPS does not discriminate against faith-based organizations.

If this IFB pertains to any school building that is being financed under Virginia Public School Authority, the administrator delegated to review this IFB for the Giles County School Board will take appropriate steps to ensure that IRS regulations regarding tax exempt bonds are not violated in the proposed contract for services.

### TERMINATION FOR NONAPPROPRIATION

Notwithstanding any contrary provisions in this Agreement, the School Board may, at its option, terminate this Agreement as of the end of its fiscal year if funds are not appropriated which, in the opinion of the School Board, are sufficient to meet its obligations hereunder. If sufficient funds are not appropriated, the School Board shall give the Vendor written notice of termination within ten (10) days after the adoption of the final budget for such fiscal year.

#### SUBMISSION REQUIREMENTS

A complete response consists of the following:

- 1. Mailed or otherwise delivered in a sealed envelope which indicates the return address of the sender, IFB number, title, receiving date, and time on the outside of the envelope.

# AWARD CRITERIA FOR NON-PROFESSIONAL SERVICES (if applicable)

Selection shall be made of two or more offerors deemed to be fully qualified and best

Invitation for Bid, including price if so stated in the IFB. Negotiations shall then be conducted with each of the offerors so selected. Price shall be considered, but need not be the sole determining factor. After negotiations have been conducted with each offeror so selected, the public body shall select the offeror which, in its opinion, has made the best proposal, and shall award the contract to that offeror. When the terms and conditions of multiple awards are so provided in the IFB, awards may be made to more than one offeror. Should the public body determine in writing and in its sole discretion that only one offeror is fully qualified, or that one offeror is clearly more highly qualified than the others under consideration, a contract may be negotiated and awarded to that offeror.

#### NON-DISCRIMINATION

Per Virginia Code § 2.2-4311 (if contract exceeds \$10,000):

- 1. During the performance of this contract, the contractor agrees as follows:
- a. The contractor will not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, age, disability, or other basis prohibited by state law relating to discrimination in employment, except where there is a bona fide occupational qualification reasonably necessary to the normal operation of the contractor. - b. The contractor, in all solicitations or advertisements for employees placed by or on behalf of the contractor, will state that such contractor is an equal opportunity employer.
- c. Notices, advertisements and solicitations placed in accordance with federal law, rule or regulation shall be deemed sufficient for the purpose of meeting the requirements of this section.
- 2. The contractor will include the provisions of the foregoing paragraphs a, b and c in every subcontract or purchase order of over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.

## **DRUG-FREE WORKPLACE**
